



## **Terms & Conditions**

### **RESERVATIONS AND PAYMENTS:**

To reserve a space, a \$500 per person **non-refundable** deposit is required to make your reservation. Final payment of the remaining balance is due 90 days prior to departure. For reservations made within 90 days, full payment is due immediately. All checks and money orders should be payable to *Peace through Yoga Foundation*. **Checks can be sent to Peace through Yoga Foundation; 7904 Pine Lake Road, Indianapolis, IN 46268. Checks should be received in five working days to confirm your space.** We also accept MasterCard, Visa, American Express and Discover **with a 3.5 service fee.**

### **PRICES:**

***GROUND PACKAGE INCLUDES:*** Accommodations and meals as indicated in the itinerary; pre-trip information; and all inclusions listed on trip description.

All rates are in U.S. dollars, unless specified. The rates are based on current tariffs and are subject to change only due to unforeseen circumstances. While we will always try to maintain the listed prices, if it is necessary to levy a surcharge, we reserve the right to do so, and notification will be given

immediately. In the event you decide to cancel because of a “Major Change,” (please see below section about definition), you will be completely refunded.

### **CANCELLATION & REFUND:**

**There is a non-refundable fee if cancelled once booking is made. The booking is 100% non-refundable after payment is made in full at 90 days prior to departure. These are PTYF’s standard cancellations fees, unless otherwise indicated differently on the website’s trip itinerary. Trip Protection is highly recommended.**

In case of a refund, please allow 7-10 days for refunds to be processed.

Leaving a trip in progress, for any reasons whatsoever, will not result in a refund, and no refunds will be made for any unused portions of a trip. PTYF reserves the right to cancel any trip because of inadequate enrollment that makes the trip economically unfeasible to operate or because of legitimate concerns with respect to safety, health or welfare of participants. If PTYF cancels a trip prior to departure, you will receive a full refund of money paid to PTYF. If we cancel the trip in progress, you will receive a prorated refund based on the number of days not completed on the trip. We will not be responsible for any refund for nonrefundable airline tickets or for any airline tickets or for any airline tickets purchased by the passenger directly from an airline or travel agent.

**TRIP PROTECTION** – Trip cancellation insurance is available at an additional cost and is *strongly* recommended.

### **ITINERARY CHANGES:**

The itineraries are subject to modification and change. Every reasonable effort will be made to operate programs as planned, but alterations may need to occur after final itineraries are sent.

### **WAITLIST POLICY:**

To be placed on a stand-by list, contact our Reservations. If cancellations are received, we call the first name on the list. These passengers then have 24 hours to respond before we contact the next waitlist, unless departure is within 48 hours or less, at which time an immediate response will be required. You will be required to pay in full upon registration.

### **TRAVEL DOCUMENTS:**

For any type of international travel, you must have a valid U.S. passport that expires no less than 6 months prior to your return date. For all PTYF trips, excluding those within the United States, a valid passport is required. Non-U.S. citizens should consult the consulate of host country regarding documentation required.

Note: Any child 17 years or younger, not traveling with both parents outside the country is required to carry a Parental Consent Form or permission letter signed by both parents and notarized at time of check-in.

Visas are also required for some trips. PTYF is not responsible for obtaining travelers' visas and this should be done through the respective country's embassy.

### **BAGGAGE ALLOWANCE & LIABILITY:**

Please check with the airlines to determine the number of bags allowed and weight limit. On our humanitarian trips, we appreciate your assistance bringing an extra bag filled with specific needed items such as school supplies, books, hygiene items, etc. PTYF will advise you of the needs of our global partner(s).

### **HEALTH REQUIREMENTS:**

You must be in good physical and mental health. Any physical condition requiring special attention, diet or treatment should be submitted in writing when the reservation is made. ### **SUPPLERS' LIABILITIES:**

Peace through Yoga Foundation makes arrangements with other direct air carriers, hotels, bus companies and other independent parties to provide you with travel services you purchase. These services are subject to the conditions imposed by these suppliers, and their liability may be limited by their tariffs, conditions of carriage and international agreements.

### **RESPONSIBILITY OF PEACE THROUGH YOGA FOUNDATION:**

PTYF is responsible for making all arrangements for accommodations and services offered in connection with the package. This responsibility does not extend to any assumption of liability for any personal injury or property damage arising out of or caused by any hotel, air carrier or anyone rendering any of the services or accommodations being offered in connection with the package. It is agreed by and between the passengers and PTYF that all disputes and matters whatsoever arising under, in connection with or incident to this agreement shall be litigated, if at all, in and before a court located in Indianapolis, Indiana, U.S.A. to the exclusion of the courts of any other county, state, or country.

### **MAJOR CHANGES:**

In accordance with Part 380 of the DOT's special regulations, the applicable Major Changes are as follows: (1) a change in the departure or return dates shown in the trip advertising unless due to flight delays of less than 48 hours, (2) a change in the origin or destination city for any flight leg other than a change in the order in which cities are visited, (3) a substitution of a hotel not named in the advertising, (4) price increases amounting to more than 10%. If Peace through Yoga Foundation knows of a major change 10 or more days before scheduled departure, you will be notified within seven days, but in any event at least 10 days before scheduled departure and otherwise as soon as possible. Time changes within the scheduled day of departure do not constitute a major change. Within seven days after receiving a pre-departure notice of a major change, you may cancel and a full refund will be made within 14 days after canceling. All of your rights and remedies hereunder are additional to other rights you may have under law, but acceptance of any refund hereunder constitutes a waiver of all such other rights and remedies.
